MEETING OF THE BOARD OF TRUSTEES OF THE

MAINE COMMUNITY COLLEGE SYSTEM

Chair Joyce Maker determined that a quorum of Trustees was present and no request from the public to address the Board of Trustees had been received. The meeting was calo order at 11:00 a.m.

ACCEPTANCE OF MINUTES

Resolution to Approve Minutes of Meetings

A motion was made and seconded to approve the Board of Trustee minutes dated February 8, 2023. The motion was unanimously approved to accept the minutes as presented.

MCCS SYSTEM PRESIDENT REPORT

President Daigler provided a legislative update, noting it is expected the legislature will pass a flat line budget in order to avoid a shutdown and will then revisit the budget to review increase items including the 4.5 % continuing request for operations/staffing, 2 year continuation of Free College, and an initiative to bring additional resources to the colleges to help support students.

A number of other bills are being followed including support for educational workforce for the learning facilitator program and a request for change the current language covering the electrical board licensing process, as well as a bill to change the name of Maine Community College System to the Maine Technical College System, which is not expected to pass.

President Daigler noted enrollments continue to be strong and the colleges are very engaged in the conversion of IT systems to a new centralized SIS platform, a request to restructure the grant with Harold Alfond, and work with Maine's DC delegation for additional support for the colleges in the resource development area.

COMMITTEE REPORTS

Education Committee

Trustee Elizabeth Neptune reported from the Education Committee meeting. The committee approved the five program reviews presented by the colleges. The following program changes were recommended approval by the trustees:

Finance Committee

A motion was made and seconded to accept the resolutions as presented. The motion passed unanimously.

Strategic Planning

President Daigler reported on Strategic Plan activities and noted the plan looks 10 years forward in identifying what the community college should look like in supporting students and the communities.

Workforce Development Committee

Trustee Kossi Gamedah reported out for the Workforce Development Committee and provided a recap of the meeting held earlier today and the two presentations focusing on the work that is being done at YCCC and throughout the system. No actions items were presented to the trustees.

President Daigler presented the following emeritus requests:

A motion was made and seconded to approve the request as presented. The motion was unanimously approved.

A motion was made and seconded to approve the request for Faculty Emeritus as presented. The motion was unanimously approved.

Presentation to Outgoing Student Trustee

Chair Maker and President Daigler presented a gift to Student Trustee Valerie Bilogue Minkala for her service to the Maine Community College System over the last two years.

PRESENTATIONS

Hana Lahr, Senior Research Associate and Director of Applied Learning at the Community College Research Center, Columbia University provided a presentation on guided pathways and how it intercepts with community college reform.

YCCC President Michael Fischer provided an overview of York County Community College, highlighting the campuses at Wells and Sanford, along with an invite to tour the Wells campus later today. Three students spoke about their experiences at YCCC.
